#### ACCESS AND MAINTENANCE EASEMENT AGREEMENT

(Windsor Villages at Ptarmigan – Landscape Improvements)

This ACCESS AND MAINTENANCE EASEMENT AGREEMENT (this "Agreement") is made and entered into as of this 25th day of August, 2023, by and between JBT ASSOCIATES, LLC (collectively, "Grantor") and PTARMIGAN WEST METROPOLITAN DISTRICT NO. 1, a quasi-municipal corporation and political subdivision of the State of Colorado (the "District").

#### **RECITALS**

- A. Grantor owns that certain real property located in the Windsor Villages at Ptarmigan, Larimer County, Colorado as more particularly described in **Exhibit A**, attached hereto and incorporated by this reference (the "**Property**").
- B. The Property contains certain landscape improvements, which may include, but are not limited to, trails, plantings, trees, shrubs, sod, ground cover, signage, and other landscape features and public improvements (the "Improvements").
- C. Grantor desires to grant the District a non-exclusive, perpetual easement for the purpose of accessing the Property and maintaining the Improvements, subject to the terms and conditions set forth herein.

#### **AGREEMENT**

NOW, THEREFORE, in consideration of the mutual promises and agreements set forth in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantor and the District covenant and agree as follows:

- 1. <u>Grant of Easement</u>. Grantor hereby grants, sells, bargains and conveys to the District, its successors and assigns, for its and their benefit, and for the benefit of its and their agents, employees, invitees, contractors, and licensees, a permanent, perpetual, non-exclusive easement, together with all rights and privileges as or incidental to the District's full use and enjoyment of its easement rights, on, over, above, under, across, and through the Property for the purpose of accessing, maintaining, repairing, operating, replacing, and/or removing the Improvements.
- 2. <u>Acceptance of Responsibility</u>. The Improvements have been constructed, subject to inspection and written acceptance by the District of operation and maintenance responsibilities of the Improvements pursuant to the written requirements, policies and procedures of the District ("Acceptance of Operation and Maintenance Responsibility").
- 3. <u>Operation and Maintenance</u>. Upon Acceptance of Operation and Maintenance Responsibility of the Improvements on the Property, the District shall operate, maintain, repair, and replace the Improvements located on the Property (the "Services") subject to taxes, fees, and

charges that may be imposed upon the Property by the District in connection with the provision of such Services. At all times following the Acceptance of Operation and Maintenance Responsibility, the District shall maintain the Improvements in good order, condition, and repair. Further, at all times following the Acceptance of Operation and Maintenance Responsibility by the District, the Grantor shall make no alterations to the Improvements.

- 4. <u>Grantor Obligations</u>. From and after the Acceptance of Operation and Maintenance Responsibility relative to the Property, the Grantor shall be responsible for payment of any and all taxes, fees, and charges imposed by the District for any Services to be provided by the District in connection with the Improvements on the Property. Such fees and charges may be imposed by the District upon the Property, and shall be invoiced by the District, and due and payable thereafter by the Grantor, on a quarterly or more frequent basis with such fees and charges based upon an annual schedule of fees and charges adopted by the District.
- 5. <u>Subject to Annual Appropriation and Budget</u>. The District does not intend hereby to create a multiple-fiscal year direct or indirect debt or other financial obligation whatsoever. The performance of all financial obligations of the District under this Agreement are subject to annual appropriation, budgeting, and availability of funds to discharge such obligations. Nothing in this Agreement constitutes a pledge of the District's credit or faith, directly or indirectly, to the Grantor. No provision of this Agreement shall be construed or interpreted as a delegation of governmental powers by the District, or as creating a multiple-fiscal year direct or indirect debt or other financial obligation whatsoever of the District or statutory debt limitation, including, without limitation, Article X, Section 20 or Article XI, Section 6 of the Constitution of the State of Colorado. No provision of this Agreement shall be construed to pledge or create a lien on any class or source of District funds.
- 6. <u>Inurement</u>. This Agreement shall run with the land and each and every one of the benefits and burdens of this Agreement shall inure to and be binding upon the parties, their respective legal representatives, heirs, successors and assigns.
- 7. <u>No Third-Party Beneficiaries</u>. This Agreement is not intended nor shall it be construed to create any third-party beneficiary rights in any person who is not expressly referenced herein as a party benefited or burdened hereby.
- 8. <u>Subjacent and Lateral Support</u>. The District shall have and exercise the right of subjacent and lateral support to whatever extent is necessary or convenient for the District's full use and enjoyment of the Easement Area.
- 9. <u>Subject to Matters of Record</u>. This Agreement and the rights granted hereunder shall be subject to any existing liens and/or encumbrances affecting the Easement Property.
- 10. <u>Attorneys' Fees</u>. Should any legal proceeding be brought in connection with this Agreement, including without limitation, actions based on contract, tort or statute, the prevailing party in such action shall be awarded all costs and expenses incurred in connection with such action, including reasonable attorneys' fees. The provisions of this Section 10 shall survive the expiration or the termination of the Agreement.

- 11. <u>Captions</u>. The captions of this Agreement are for convenience and reference only and in no way define, describe, extend, or limit the scope, meaning, or intent of this Agreement.
- 12. <u>Entire Agreement</u>. This Agreement constitutes the entire understanding and agreement between the parties with respect to the subject matter hereof, and supersedes all negotiations or previous understandings or agreements between the parties with respect to all or any part of the subject matter hereof.
- Governmental Immunity. Nothing in this Agreement shall be construed to limit, modify, or otherwise constitute a waiver, in whole or in part, of any governmental immunity that may be available by law to the District, its respective officials, employees, contractors or agents, and in particular, the District's rights and protections under the Colorado Governmental Immunity Act, §§ 24-10-101, et seq., C.R.S., as amended from time to time.
- 14. Governing Law. This Agreement, including all questions concerning the construction, validity and interpretation of this Agreement, and the exhibits hereto, and all claims or controversies arising out of or relating to this Agreement, shall be governed and construed under the applicable laws of the State of Colorado, without regard to conflict of law principals that would result in the application of any law other than the law of the State of Colorado. Venue for all actions arising from this Agreement shall be in the District Court in and for Larimer County. The parties expressly and irrevocably waive any objections or rights which may affect venue of any such action, including, but not limited to, *forum non-conveniens* or otherwise.
- 15. <u>Severability</u>. If any portion of this Agreement is declared by any court of competent jurisdiction to be void or unenforceable, such decision shall not affect the validity of any remaining portion of this Agreement, which shall remain in full force and effect. In addition, in lieu of such void or unenforceable provision, there shall automatically be added as part of this Agreement a provision similar in terms to such illegal, invalid or unenforceable provision so that the resulting reformed provision is legal, valid and enforceable.
- 16. <u>Recording</u>. This Agreement shall be recorded in the real property records of Larimer County, Colorado.
- 17. <u>Grantor Authority</u>. Grantor covenants and agrees with the District that the Grantor has full power and lawful authority to grant, bargain, declare and convey the easement granted herein to the District. The Grantor further promises and agrees to warrant and forever defend the District in the exercise of the District's rights hereunder against any defect in the Grantor's title to the Easement Area and the Grantor's right to make the grant described herein, except matters of record.
- 18. <u>Counterparts</u>. This Agreement may be executed in several counterparts, each of which may be deemed an original, but all of which together shall constitute one and the same instrument. Executed copies hereof may be delivered by facsimile or email of a PDF document, and upon receipt, shall be deemed originals and binding upon the signatories hereto, and shall have the full force and effect of the original for all purposes, included the rules of evidence applicable to court proceedings.
